## Have You Received Seeds from China?

You may have heard about the reports of unsolicited packages of seeds being mailed to people across the United States that appear to originate from China.

If you get seed that you did not purchase, contact the Arkansas Plant Industries Division at 501-225-1598, or email <u>Paul.shell@agriculture.arkansas.gov</u> or <u>Mark.stoll@agriculture.arkansas.gov</u>, or bring them, unopened, to the Miller County Extension Service. We are located inside of the Miller County Courthouse, 400 Laurel, Room 215, Texarkana, AR.

The Arkansas Department of Agriculture will advise what to do. Seeds should NOT be removed from their packaging and should NOT be planted. Investigators could be sent to retrieve the seed and will likely want to see the envelope and packing materials the seeds were sent in.

The Arkansas Department of Agriculture and other state departments of agriculture are working with USDA APHIS to determine what is going on and the risk. Per Paul Shell with the Arkansas Department of Agriculture, the concern is that there could be an introduction of a potential invasive weed, insect or plant disease associated with these shipments.



We have received a couple of packages that members of the community have received in the mail. The Department of Agriculture has been contacted and will pick the packages up.

# Volunteer Time

I hope everyone is doing okay & staying safe. Here is an update of how we are doing right now. First, I have one request of you. *Please* place any volunteer hours you have into the system. Your hours are <u>*really needed*</u> this year, since we have had to scale back so much because of Covid. I find the longer we wait, the harder it is to remember when and how many hours we have earned. I also know there are some of you that have hours and have not placed them into the system.

Current membership is 80; of that 10 are Lifetimers, 59 regular members and 11 trainees. We are up to 100% of our membership as active. You may notice that you have an additional hour of education. I gave everyone 1 hour of education this month. The state wanted us (online managers) to activate all of our members. To be active, you must have at least one hour in the system. So, to be fair, everyone gets 1 hour of education.

I want to congratulate from our 2019 MG Trainee class Douglas Fant, Barbara McWilliams, and Wendi Merkel; they are now Certified Master Gardeners. BIG Congratulations to you all.

This month we add the following members that have enough volunteer hours in for recertification. Congratulations to Linda Emert, Peggy Groves, Annette Lackowsky, and Jane Richards. GREAT JOB.

So far this year, 1575.25 sanctioned hours, 67.25 nonsanctioned hours and 963.75 education hours have been placed into the online system. This is great.

Below are the normal requirements for Master Gardeners. Since this year is not normal, I believe the Executive Committee is going to make some changes to our yearly requirements.

**2019 Trainees (Annuals):** You need 20 Sanctioned, 20 Non-Sanctioned & 20 Education hours for recertification.

**Membership (Perennials):** You need 10 Sanctioned, 10 Non-Sanctioned & 20 Education hours for recertification.

**Lifetimers:** You need 10 Sanctioned hours to keep your years counting.

Remember, all hours are important & needed to keep the MG programs going, so please report all hours. To report hours, go to <u>www.uaex.edu</u>, then Yard & Garden. Click on Master Gardener Program, then Enter Volunteer Hours here and logon. This is the best way to ensure you are at the current version of the online reporting system.

I know that the stay in place and social distancing order is making it more difficult to do volunteer hours, but there are still a few things you can do and still stay in place.

### When to Wear a Mask?

A question many MGs are asking is "Do we have to wear a mask if we are outside more than 6' apart while working on projects?"

Berni Kurz, MG State Coordinator, Instructor Consumer Horticulture, said: "We do not have to wear masks outside if we are social distanced at least 6 feet apart. If you are in a close group working on a flower bed (and not able to be six feet apart) for example, you might need to put a mask on."
