The price summary is provided to illustrate current, statewide market trends in timber product values for standing timber. These values may not reflect the stumpage values for a particular tract of timber. Timber prices may vary greatly depending on many factors including: location in the state, species, products, access, distance to mills, and site conditions. Trends: Prices for all products have remained steady or experienced slight increases since 2013. Pine sawtimber again experienced a slight decrease. Pine pulpwood demand remained low. Hardwood markets remained stable with good prices overall. Overall, timber markets remained stable in the 3rd quarter 2015.
