



Arkansas Rice Research Verification Program Weekly Update May 30, 2025 – Update No. 7

General Information

Fertilizer and herbicide applications continue slowly between periods of rain. The rains have been beneficial for Jefferson, Lonoke and Prairie Counties which have their permeant floods established. Irrigation has been little to mostly none. Fields at the 3rd to 4th tiller stage awaiting fertilizer or spraying include Chicot, Poinsett and White Counties. The Desha County (FIR) field got its 2nd fertilizer application and is at the panicle initiation (PI) stage. Poinsett County is at the 1st tiller stage. Woodruff County was drill-seeded on 5/14 with emergence on 5/20.
