General Information

The weather continues to dominate herbicide and fertilizer applications. Pre-flood N is scheduled for Jefferson County while the Desha County field is scheduled for its 2nd shot of nitrogen. Chicot, Crittenden, Jefferson, Lonoke and White Counties are at the 1st Tiller stage. Poinsett and Prairie Counties are at the 3-leaf stage. Woodruff County was able to get planted yesterday 5/14.
