RE: NAEPSDP Committee Report & Recommendations

The Resolutions and Policy Committee has completed a detailed review of the NAESPDP Constitution, Bylaws and Policies and Procedures.

Recommendations for amendments to the Constitution and Bylaws must be circulated at least 30 days prior to the annual meeting in December.

Please review the proposed resolutions in preparation for the vote at the NAEPSDP annual business meeting at the national conference.

The steps utilized to inform this process included:

- 1. Membership Survey
- 2. Creation of Editing Documents (documentation of member proposals by numbered line for Constitution, Bylaws and Procedures review)
- 3. Individual committee member review of membership survey results and editing documents
- Committee meetings conducted on August 21st and September 17th through Zoom for document review and collaborative editing
- 5. Board review and survey with feedback

Key Constitution/Bylaws Survey Take-Aways from Member Survey:

- Consistency needed in documents
- Formatting errors need to be corrected
- Update and increase clarity of some sections
- Clarify/update officer roles & responsibilities
- Add timelines
